9. Latest Bank Statement of the last six months (duly verified by the Bank with stamp) showing a minimum closing balance of not less than Rs.5 lacs;
10. Original Affidavit of the Owner/Publisher as specified on stamp paper of Rs.100/-duly attested by Oath Commissioner;
11. Original Affidavit of the Owner/Publisher for the source of funding as specified on stamp paper of Rs.100/-, duly attested by the Oath Commissioner.
