DOCUMENTS REQUIRED FOR TRANSFER OF OWNERSHIP OF PUBLICATION

- 1. Copies of <u>Valid CNIC</u> of the <u>Publishers (Incoming and Outgoing)</u>, <u>Editor</u> and <u>Printer</u> (duly attested by a Government Officer in BS-17 or above);
- Attested Photocopy of applicant's master's degree/ bachelor's degree (with 16 years of schooling) with
 original HEC attestation stamp. In the case of a Foreign/Local/Deeni Asnad or an Equivalent degree, the
 Equivalence Certificate issued by the HEC is mandatory;
- 3. <u>Original Certificate of 5 years of experience</u> in journalism of a Registered CML listed Newspaper issued by the Chief Editor/ Publisher on the original letterhead of publication with Name & Stamp, along with supporting documents including original news clippings, attested copies of employee ID cards and salary slips for the working period;
- 4. At least <u>10-15 original published articles/news stories</u> printed during the period mentioned in the experience certificate with the name of the applicant to verify the certificate;
- 5. If the applicant is a <u>professional degree holder</u> (e.g. medical or engineering) and applied for a title in that specific professional field then he/she shall furnish an experience certificate and news clippings/articles in that respective field not in the journalistic field;
- 6. Original Receipt of fee for NOC duly verified by Treasury Officer; Rs. 5000/- for Karachi, Lahore, Islamabad, and Rawalpindi stations, whereas for the rest of the country, the fee is Rs. 1,000/-(On 32-A Challan Form in any branch of NBP / State Bank in A/C # C03886, Account Title: Government of Pakistan);
- 7. <u>Latest Bank Statement of the last six months</u> (duly verified by the Bank Manager, with stamp) showing a minimum closing balance of not less than Rs.5 lacs;
- 8. Copy of **NOC of Press Registrar** for allotment of Title Name;
- 9. Copy of **NOC of Press Registrar for previous Transfer** of Ownership of Title;
- 10. Attested Copies of **Declarations Form-B** of outgoing **Publisher** and **Printer**;
- 11. Attested Copy of **Declaration Form-A** of **Printer**;
- 12. Copies of the Registration certificate(s) of allotted stations;
- 13. True Attested copy of **Regularity Certificate(s)** of all allotted stations;
- 14. Three months issue of publication of all allotted stations;
- 15. <u>Original Affidavit of Incoming Publisher</u> as specified on stamp paper of Rs.100/-, duly attested by Oath Commissioner;
- 16. <u>Original Affidavit of Incoming Publisher for the Source of Funding</u> as specified on stamp paper of Rs.100/-duly attested by Oath Commissioner;

- 17. Original Affidavit of Outgoing Publisher for the Source of Funding and clearance of Employee's dues as specified on stamp paper of Rs.100/- duly attested by Oath Commissioner;
- 18. <u>Sale agreement</u> b/w both parties on a legal stamp paper specified for the sale deed duly attested by the Oath Commissioner.
- 19. <u>In-person attendance of incoming and outgoing owners</u> before the Press Registrar or Designated Officers, as the case may be. <u>Attendance Sheet to be signed with thumb expressions by both incoming and outgoing owners and duly verified by the Press Registrar/Designated Officer;</u>
- 20. To transfer ownership of a registered title after the owner's death, the applicant i.e. the nominated legal heir must provide the following documents; (i) the death certificate of the owner, (ii) FRC from NADRA, (iii) succession certificate, (iv) certified copy of the complete file of the civil suit filed by the nominated legal heir along with all annexures and replies/comments of the respondents, (v) a certified true copy of the court decree containing the applicant's nomination. The court decree must clearly state that other legal heirs have surrendered their ownership rights to the title in favour of the nominated heir;

- Incomplete proformas shall not be entertained.
- Applications with all requirements submitted through proper channels i.e. Regional designated officers in PID/ RIO offices shall be entertained.
- A title shall be transferred from its all declared stations to the Incoming Publisher.
