- Attested copy of Declaration (Form A) of incoming Printer;
- Copy of Registration Certificate of Publication;
- True Attested copy of Regularity Certificate;
- Three months latest issue of publication;
- Original Receipt of fee for NOC duly verified by Treasury Officer; **Rs. 5000/-** for Karachi, Lahore, Islamabad, Rawalpindi stations, whereas for rest of the country fee is **Rs. 1,000/-** (On **32-A Challan Form** in any branch of **NBP / State Bank** in **A/C # C03886**, Account Title: **Government of Pakistan**);
- Bank Statement of last six months (duly verified by the Bank Manager, with stamp) showing minimum closing balance not less than Rs.5 lacs;
- No Objection Certificate from Outgoing Printer about clearance of dues of employees and clients duly signed and stamped as specified on original letterhead of printing press;
- No Objection Certificate from Incoming Printer duly signed and stamped as specified on original letterhead of printing press;
- Original Affidavit of Applicant (Owner/Publisher) as specified on stamp paper of Rs.100/-duly attested by Oath Commissioner;
- Original Affidavit of source of funding and clearance of dues of employees as specified on stamp paper of Rs.100/-, duly attested by Oath Commissioner.
- Authority Letter of Competent Authority (CEO/ Head of Organization) with nomination of Publisher on original letter head; **(if applicable)**
- Attested copy of registration certificate of company/authority/etc. along with affidavits verified by the concerned registration authority;**(if applicable)**
