- Copy of academic qualification attested by Govt. officer of in BS-17 or above with the stamp by name;
- Bank Statement of **last six months** (duly verified by the Bank Manager, with stamp) showing minimum closing balance not less than Rs.5 lacs;
- **Detail of Machines** with purchasing receipts and Financial feasibility plan for the proposed Printing Press;
- Original Receipt of fee for NOC duly **verified by Treasury Officer; Rs. 5000/-** for Karachi, Lahore, Islamabad, Rawalpindi stations, whereas for rest of the country fee is **Rs. 1,000/-** (On **32-A Challan Form** in any branch of **NBP / State Bank** in **A/C # C03886**, Account Title: **Government of Pakistan**);
- Original Affidavit of Applicant (Keeper of Press) as specified on stamp paper of Rs.100/-, duly attested by Oath Commissioner;
- Original Affidavit of owner for source of funding as specified on stamp paper of Rs.100/-, duly attested by Oath Commissioner;
- Authority Letter of Competent Authority (CEO/ Head of Organization) with nomination of Publisher on original letter head;
- Attested copy of registration certificate of company/authority/etc. along with affidavits verified by the concerned registration authority;

- ***Applications with all requirements submitted through proper channels i.e. Regional designated officers in PID/ RIO offices, shall be entertained.***
