Subject: REVISION OF FEE FOR NOC AND REGISTRATION CERTIFICATE

To facilitate the media by discouraging dummy and fake publications, the fee structure of the office Press Registrar has been revised.

The new fee for the Registration is Rs. 10,000/- only. The fee for all NOC will be 5,000/- only.

In case of violations of Act of Parliament and the above fee structure rules a penalty ranging between 5,000/- to 20,000/- only will be imposed.
